Dear Friends,

We greatly appreciate your valued partnership and support over many years, and we are especially thankful for you in the past year.

Loaves & Fishes continues to provide healthy food and impactful programs to promote self-sufficiency, and we are always considering new, innovative ways to achieve this. Through both our Grocery Assistance and CARES Programs, our goal is to promote long-term results for families and individuals struggling with hunger and economic instability.

Our Grocery Assistance Program distributed approximately 3.9 million pounds of food last year. We continue to focus on regular access to healthy food, offering more nutritious options through our Smart Check program. We are providing more milk and eggs and adding service to underserved areas and at-risk populations such as children and seniors. An additional refrigerated truck has increased the capacity of our food recovery program, and has enabled us to make more than 105 weekly pick-ups to more than 24 grocery partners. We obtained approximately 2.2 million pounds of food directly through our food recovery program which provides greater access to healthy food for our clients and reduces waste by rescuing food that would otherwise have ended up in landfills.

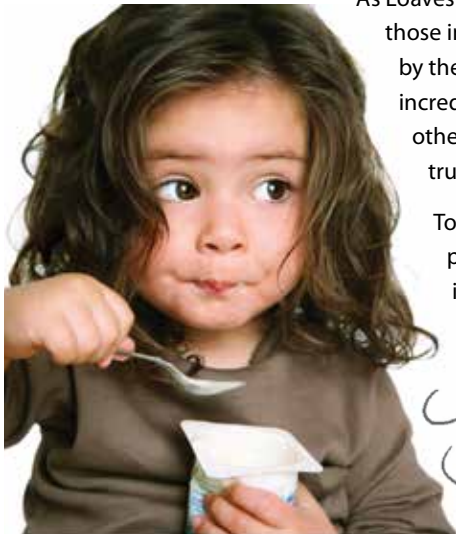
