Over the past year, the number of clients we served over doubled. We are very fortunate to be able to provide many more people with healthy food and services. And importantly, they now have multiple ways to access the help they need.

We have focused on the lessons we have learned along the way. In our last Strategic Plan, to serve the community's growing need we had to rethink our model of how we provide food and services. Our new model needed to be more scalable, expansive, efficient, flexible, and adaptable. We didn't know where this would lead us, but we knew we had to think big to accomplish these objectives. Thinking big allowed us to implement a new hub and spoke model that has performed very well despite the headwinds of a pandemic and economic turmoil.

As we look forward, expanding and deepening relationships will be an even greater priority. 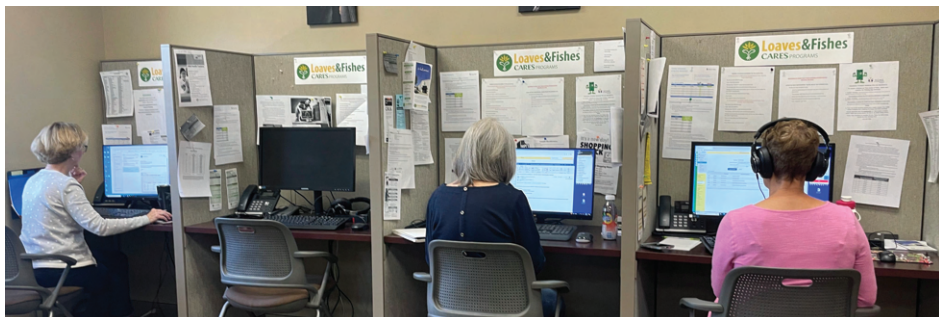

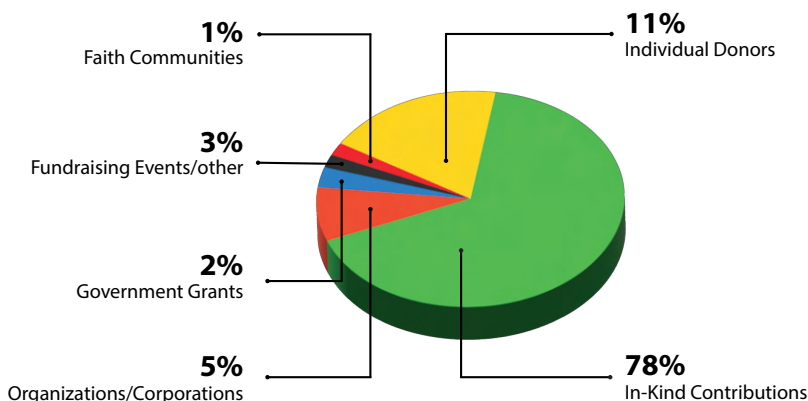
